TREES and COMMON AREAS

We currently have some Evergreen Trees along Murlen that have died, we will be removing these in the near future.

I've also asked the tree company to remove all volunteer trees that are growing on the common area side of the fences, this will help keep the lines looking clean.

If you've planted anything in the common area, you need to clean up the area around the planted areas.

If volunteer trees are growing up inside the bushes then leaves catch and the lawn care crew cannot get the leaves to blow out. If your fences back up to Murlen and/or 127th Street, please help remove trash that blows into the fences or under the bushes.

The lawn care company is not responsible for cleaning up trash, if the trash is in the mowing area they will pick it up but stuck under a bush or along a fence, this is not their job.

People throw liter out the windows of cars and or off trash trucks and the fences catch them, please help keep our area looking nice.

We have had 3 globes busted, either by accidently hitting with a ball, but a couple of the globes had holes either from rocks or bb's. Remember your dues are paying for the replacement of these globes and lights.

We have one light pole down, a new pole has been ordered. It should be coming soon.

If you see any of the mowers hit a light pole please send an email ASAP or make note that you witnessed the pole get hit and date and time. Your help in this matter is appreciated
